## **DEPOSITS**

A minimum deposit is required at time of booking your Ski Holiday of \$1500.00pp plus payment for flights and land if required. Bookings will only be accepted with the signed Booking Form and the appropriate deposit.

## **PROGRESS PAYMENTS**

Deposits due within 5 days of Booking with final payment due October 2025 for Ski Holidays, dates will be advised.

## **AMENDMENTS**

A confirmed booking may incur charges for change, unless it involves a cancellation fee. Third Party amendment fees may apply also.

## **COSTS**

The advertised tour cost is expressed in Australian dollars, based on costs, charges, fares, tariffs and currency exchange rates at the date of issue and are subject to change with or without notice. Tour cost & group rates are calculated on a minimum of 25 participants, with payment by cash, cheque or direct deposit to Estours Commonwealth Bank account. Tour cost may vary if minimum group size is not achieved. Payments by credit cards will incur a fee. This tour is a complete holiday package and itemization of costs will not be rendered.

## **CANCELLATION**

Airfares are subject to cancellation fees of up to 100%. All cancellations irrespective of date of cancellation will incur a minimum fee of \$250 per person. Cancellations prior to departure incur a fee dependent on time of cancellation. Land package cancellation policies vary depending on charges levied by the hotels, transport companies and service providers, and third party booking agents which can be as high as 100% of travel cost.

## **INSURANCE**

We strongly recommend you take out travel insurance to cover cancellation charges, personal accidents, loss or damage to luggage, medical expenses, evacuation and personal liability. If you decline to take out travel insurance, we will require you to sign an indemnity form. Should you obtain insurance separately then Estours Travel will require a copy of the policy and contact details for use by our tour leader, if necessary.

## **BAGGAGE**

Free baggage allowance depends on your airline, up to date information will be found on the airline websites. Check with your airlines for allowances for ski and sporting equipment. Ground

Transportation may require extra payment for ski bags. Please advise at time of booking.

## **TRAVEL DOCUMENTS**

All passengers departing Australia need valid passports. You may need a re-entry permit to Australia if you are traveling on a passport of another nationality. The validity of a passport must extend at least 6 months past the return date to Australia. It is the passenger's responsibility to ensure that they are in possession of the necessary travel documentation and that they comply with the appropriate government and transportation regulations. Online Visa waivers may be required for travel to Canada and the US.

## **COSTS DO NOT INCLUDE:**

Passport and visa fees, airfares (except as specified), fuel surcharges and airport taxes, excess baggage charges and all other costs of a personal nature, not specifically included. Additional costs caused by weather or failure of transportation services or other circumstances outside the control of the tour operators or their principal or agent, are not included but may be covered by the passenger's own travel insurance.
